## **Any other business**

Correspondence had been received from Cormac of a damaged bench at the bus stop on Phernyssick Road. Details were included that there was grant funding available to enhance the bus stop. It was agreed that an application be made.

The Clerk read details of the procedure for new councillors now that the requisite time for election had passed and the co-option process now takes effect.

A request from Matt Healey, Westcountry Rivers Trust to give a presentation on the work that has been completed at Lower Molinnis Moors. The planning meeting on January 10<sup>th</sup> to be offered as a suggested date.

The Clerk referred to an enquiry from Stenalees Bowling Club regarding the possibility of support in acquiring some adjoining land owned Cornwall Council. He added that talks were ongoing that could possible devolution of the land and nearby park/play area with assistance of the shared prosperity funding.

Correspondence read from Arcadis re the temporary accommodation for Sky Primary Academy stating further delays at the West Carclaze Garden Village site and the need for proposed extra accommodation at the Eden Project Cherry car park.

An invitation from Time2Move Holiday Activities and Food Fund to deliver a programme locally with sessions from December 19 -23. The Clerk confirmed that he had passed on this information to Bugle Youth Club/ Messy Monsters and Treverbyn Community Hall.

It had been anticipated that there would have been some members of the public attending re the ongoing issues at Carthew with inconsiderate parking. It was confirmed that there had been no further

contact from St Austell Brewery or the landlord. It was suggested that it be made an agenda item at the next council meeting on November 28<sup>th</sup> and to invite various interested parties to attend.

Councillors requested that Enforcement Department be informed of the removal of a stretch of Cornish hedgerow at Drummer's Hill and of a large caravan that has been located in a garden at Carthew.

Cllr Mrs A Wills thanked Council for the beautiful flowers and card during her recent convalescence.

It had been reported to Council that the service lane to Mr J Kent's property at Bojea Mill has now been covered by tar-mac.

The Clerk explained to Council that he had received a CIL payment £5543.64 for a development in Bugle and requested that this money be transferred from the Current a/c to the Business Reserve a/c until it is required. Proposed by CIIr Mrs A Wills, seconded by CIIr Mrs J Burnhill. All in favour.

Correspondence was read from Cllr Mrs A Ellis requesting a period of 6 months leave of absence for family reasons. Councillors unanimously agreed to the request.

The Clerk reminded Councillors of the details of the Remembrance Service on Sunday November 13<sup>th</sup> .
