PLANNING MEETING held on February 25th 2025

There were six members of the public present that included a prospective new councillor (observing), three representatives from the developers of West Carclaze Garden Village and two representatives for application PA25/00947.

Public Participation:

After welcoming everyone to the meeting the Chairman, Cllr Mrs A Roberts invited Mr Dorian Beresford to give a presentation on the current aims of the developers of West Carclaze Garden Village. He commenced by stating that the school will be handed over to the Trust in June and will open in September with the school hall being available to act as a community facility. He continued by giving details of a food hall that will be self-sufficient, the country park and the possibility of a dental surgery. He then enlarged on an annual contribution funding scheme to work in collaboration with Treverbyn Parish Council to assist in the management and maintenance of local community facilities. He requested that the Council considers and agrees to this proposal in order for him to complete further talks and negotiations with Cornwall Council.

6.50pm: Cllr Mrs M Thomas arrived and at 6.58pm: Cllr K Pollard arrived for the meeting.

Mr Beresford continued by enlarging on the overspend incurred on various aspects of the site and the financial pressure and cost implications in producing the best value homes and amenities. In order to maintain the required standards, he asked the Council to give their support to back a proposal to set the target of affordable homes at 25%.

He then answered various questions from members of Council.

The Chairman thanked the representatives for the information provided and they left the meeting.

Mr R Skinner then gave more details on his application PA25/00947 and answered issues raised by councillors.
